
Educational Options Before Learning Support Suspension

Students who are not CPC deficient and have one attempt in English or Reading or two in MATH 0097/0098 and are not yet suspended, may be advised to

- transfer to a technical college and complete learning support there. A student who attended a SACS-COC TCSG college and exempts or exits Learning Support there will have their LS requirement satisfied at GPC.
- transfer to a private or out-of-state college, complete a college-level class equivalent to ENGL 1101 or MATH 1101/1111 with a grade of C or better, and transfer this course back to GPC. This college-level course will fulfill the LS requirement in the LS area.

If a student is CPC deficient in an area and earns transfer credit in that area from a non-USG institution or from a non-SACS-COC accredited TCSG institution, he or she may not exit LS through the transfer credit. The student must complete the LS area at GPC and take the appropriate exit test. The transfer credit can be used in the Core Curriculum once the LS requirement is satisfied and the exit test is passed.

Educational Options After Learning Support Suspension

Students who are suspended from Georgia Perimeter College and all University System of Georgia institutions for one year because they have not completed a Learning Support area in three attempts in Mathematics, two attempts in English or two attempts in Reading *may* attend a technical college, a private college, or a college out-of-state.

After Being Out of School for One Year - If the student sits out of college for the full one-year period of the suspension and then returns to GPC, he or she will take the Compass placement test in the area of the suspension and all other Learning Support areas that have not been exempted or exited previously. If the student passes the placement test in an area, he or she will be exited from Learning Support in that area. If the student does not pass the placement test in an area, he or she must take the required Learning Support classes in that area and attempts will start over.

Conditions for Early Return - Students may return to GPC before the end of the one-year suspension if the following conditions are met:

- The student attends a SACS-COC accredited technical college* and brings an official passing score on either Compass or Asset at the technical college in the area of the suspension and attended that college. The student may need to specially request this test if it is not required at the technical college.
 - In English, the passing scores are 64 for Compass and 43 for Asset.
 - In Mathematics, the passing scores are 37 for Compass and 42 for Asset.
 - In Reading, the passing scores are 78 for Compass and 41 for Asset.
- The student brings transfer credit in ENGL 1101 or its equivalent (if the area of suspension is English or Reading) and/or have transfer credit for MATH 1101 or MATH 1111 or higher mathematics (if the area of suspension is Mathematics). If the student does not have an exiting test score, the student must take the placement test with GPC and abide by that placement unless the student also has 30 semester hours of acceptable transfer credit in addition to the college-level credit in the area of the suspension to satisfy the LS requirement.
